HS 3 Submission to Government on Wellington Regional Hospital

Michael Vincent, Booz Allen and Hamilton, presented a transport analysis for the Wellington regional hospital. Mr Vincent tabled a summary of his presentation for members.

The Chair advised that the Wellington Regional Council had received from the Ministry of Health an extension of a few days to make its submission.

Michael Green, Hazard Analyst, Resource Policy, presented an analysis of the potential earthquake risks to the Newtown and Kenepuru sites. Members would receive copies of Mr Green's report.

Members generally agreed that the Council's submission should speak with strength on issues within its relevant areas of expertise, that is, transport and hazard risk management.
