- Was there an overall goal for Parks and Forests marketing; need to avoid "either/or" messages? (balancing fun with fitness)
- Could there be greater co-operation between groups involved in marketing recreation and tourism in the region?
- When/how will park signage be improved? Could signage be promoted on public transport? Should signage include greater inducements for park recreation?

- Links noted to the Concessions Policy and to other parts of the Council eg eco-tourism and catchment access (liaison with Iwi will be important).

Mr Annakin noted the points raised in the discussion and would report back to the Committee as the strategic direction was implemented.
