## **Matters for Consideration**

### HRA 03 **Hutt River Flood 5/6 January 2005**

#### **Oral Report by Mr Dick, Manager, Flood Protection**

Mr Dick explained the river flows, flood damage and the response strategy during the recent flood on the Hutt River between 5 and 6 January 2005. Mr Dick explained the damaged areas as follows:

- There will be the usual clean up of the berms, access tracks, the Hutt River trail, top ups to existing rock structures and some in-channel work, etc.
- Key stress areas are the bed degradation at Elbow Park/Maoribank, bank erosion adjacent to the Manor Park golf course, and the need to repair and strengthen the existing Avalon works.
- There will be need for a 150 metre extension of bank stabilisation works at the downstream of the Manor Park golf course. Discussions with interested parties will be held before a more comprehensive solution can be considered.
- The flood risks to the Hathaway Avenue properties will remain until the new stopbank is constructed. Meantime, a meeting will be held with residents to get some improved flood warning procedures in place.
- Gravel levels in the lower river appear to have been a factor in the increased flood levels. While Greater Wellington recently increased the amount of gravel extraction from the river, a more aggressive gravel extraction programme may need to be adopted.
