Adrian Webster, of the Paekakariki Community Board, maintained that his group had not been consulted about Greater Wellington's plans for replacement of the historic barn at Queen Elizabeth II Park. He requested that the issue be revisited, and that his group be given 6 weeks to present an alternative. Mr Webster noted that there was already \$60 000 available to restore the building, and that KCDC had expressed a willingness to assist with finance.

John Lancashire, of the Friends of Queen Elizabeth II Park, supported Paekakariki Community Board's position. He also maintained that his group had also not been consulted.

Mr Lancashire feels that heritage issues are important, and reported that an increasing number of tourists are passing through the area. He predicted that horse trekking will become very popular in the future. His organisation is prepared to help with finance.
