Clare Pascoe expressed support for the report on the integration of cycling and public transport.

Rosamund Averton expressed appreciation for the removal of *Contravision* from some buses. She also requested that suburban bus services be extended in weekends, and that more use be made of Wellington Harbour for public transport.

Brent Efford spoke critically of the Ngauranga to Airport draft corridor plan.

Mike Mellor expressed support for the report on the integration of cycling and public transport, and for the Seatoun ferry service. He also expressed reservations about the Ngauranga to Airport draft corridor plan.

T&A 43     **Ngauranga to Wellington Airport – Draft Corridor Plan**

- (1)     Receives the report.*

- (3)     Agrees to endorse the draft Ngauranga to Wellington Airport Corridor Plan and forward it to the Regional Land Transport Committee for it to lead a public consultation process in conjunction with study partners Wellington City Council, Greater Wellington Regional Council, and Transit New Zealand.*

*That the Committee includes the following resolutions proposed by the Wellington City Council:*

- (a)     That the plan includes working with private carpark owners to alter tariffs to reduce the current arrangements that favour long stay parking (commuters) over short stay (shoppers and users of services).*
- (b)     That during the consultation period, modelling work is done on a scenario including a significant change in the price of private motoring (capital and operating), the implementation of the Wellington City growth spine, and the impact of proposed developments in the eastern suburbs (e.g. Rongotai retail area, indoor stadium, and improvements to airport bus services).*
- (c)     That detailed “scheme assessments” for a high quality public transport system, Mt Victoria tunnel duplication, Terrace tunnel duplication, and four-lane Ruahine Street-Wellington Road be conducted within the period of 5-10 years (i.e. after the first review of the plan).*

- (4a) Notes that the RLTS includes a target to reduce Co<sub>2</sub> emissions to below 2001 levels.*
- (4b) Requests officers to significantly increase engagement with Central Government agencies to investigate ways which the region can reduce transport-generated greenhouse gas emissions.*

  - c. *Ensure through this communication that cyclists understand the conditions that apply for the transport of bikes on trains i.e. there is no guarantee of carriage, and carriage is on a “first come first served” basis.*
  - d. *Monitor bike carriage.*
  - e. *In association with Tranz Metro, set a minimum/maximum number of cycles able to be carried per compartment/carriage i.e. no more than the maximum can be carried, but so long as this number is not exceeded, then a bike must be carried (but subject always to available space).*
  - f. *Investigate in collaboration with Tranz Metro and (potential) users whether the new Wairarapa SWG cars can be equipped with measures to improve the transport of bikes.*
  - g. *Investigate using the Wairarapa AG van in summer and at other times likely to be popular with cyclists.*

- h. Ensure suitable capacity for bikes and other large items is included in the design of the new trains.*
- i. Review the situation prior to the introduction of the new trains.*
- 4. *Asks officers to*
  - (a) report back on arrangements set in place.*
  - (b) make appropriate amendments to the Passenger Transport Operational Plan.*
  - (c) report back on the carriage of bikes on Christchurch buses.*
