## Request for information 2022-133

I refer to your request for information dated 22 August 2022, which was made to Hutt City Council (Hutt City) and transferred to Greater Wellington Regional Council (Greater Wellington) on 23 August 2022. You have requested the following:

"Please forward me all communications between the Hutt City Council and Greater Wellington Regional Council concerning converting carparks outside Hell Pizza and Subway into a bus stop. Please also forward all safety assessments of the existing Jackson Street bus stop that is being relocated to 340 Jackson Street."

just to keep you posted on this (I have advised the bus company), the canopy is getting hit on about a fortnightly basis at the moment (see photos from 2 weeks ago and a new one from this morning).. I'm not sure why but it is a concern at my end for public safety as we have no idea how safe it is or if the debris is a risk.

I'm not sure who's liable here BUT it would be great to have some clarity here around what we can do to make this safe, while we wait for documentation etc, and approvals etc? Perhaps something temporary so the buses stop swooping in so close.

The obvious thing to do would be to move the bus stop next door as they have no canopy at all..

Any advice appreciated.

Hi there, following on from the correspondence below - we are in the process of trying to replace the current canopy due to the damage caused by the buses, for some reason the buses are hitting the current one on a more regular basis and it was given a big bang last week!

While going through this process I'am wondering if the council would consider moving the bus stop 20m down the road where there a no canopies at all... as per the picture attached, one of your staff have proposed the temporary bus stop while we do the work but common sense would suggest this would be a cheaper and safer option (as the council will need to pay to widen the footpath etc)

This would give us peace of mind and provide safety to the public as we are concerned with the amount of damage being done to our canopy and any risk to the public.

Dear

Thank you for contacting us about the property you purchased at 226-338 Jackson Street Petone and the damage the canopy attached to the building has sustained.

We are aware of this issue and measures have been put in place to guide buses when they are in the area. These will be reviewed to see what else we can in the short-term to stop this from happening. The operator has also been told to remind their drivers take extra care when they go past your property. A discussion is being held with Hutt City Council about a long-term solution. We hope to finalise these designs later this year as part of a programme to enhance a few stops on Jackson Street. If you do have any further problems, if possible, please try and obtain details of any buses involved. This could include fleet, license plate number, and/or video footage.

On our part, we will do our best to sort this out in terms of finding a permanent fix for this issue.

no worries happy to chat about this.

Ah I see – that is much the case elsewhere in Wellington with canopies- very hard to remove them!

Yes logically speaking- it does make sense to keep the stop where it is now under its temporary relocation-however, to make this the permanent location of the bus stop, we would need to go through a formal consultation process with business owners directly affected to see whether they support the relocation or not- and judging by the negative reactions to the bus stop relocation by business owners, it may prove difficult to settle the bus stop there permanently.

We will discuss internally our next steps and whether we should look at consulting the businesses on permanently relocating – or continuing with plans to carry out the kerb build out at the bus stops original location.

It is great to make contact with you and know we have your support should we go down the track of formal consultation on stop 8006's permanent relocation.

To note- during the next 12 months, we will see how the bus stop operates in its new location, and we may even find that this new location becomes a preferred one by all.

Thanks for your email Leona, thats great info.

Yes that's our canopy and unfortunately we can not remove it as Petone heritage & council won't let us. We do plan to refurbish or completely rebuild it depending on how bad the damage is once we remove the linings.

We are required by council and heritage to rebuild the canopy as it is exactly now.

Unfortunately with all the hoops we have to jump through to get a days work done on this we are probably a fair while off being given the go ahead to start this work.

As per my email I'd suggest saving the hassle & cost of building out the kerbline and leaving the bus stop where it is now, there are a number of reasons (mostly safety) for this and if you know the area it just makes sense!

As below I'am more than happy to meet you out onsite or come in for a chat anytime to explain the case above to relocate this permanently as it is now.

Good morning

Susannah has kindly passed this conversation onto myself as I was the one that instigated the bus stop relocation to outside Hells Pizza and Subway to be clear of the canopy at 338 Jackson Street.

As you are probably aware, we had to recently relocate the bus stop as we have had a sudden increase in successive strikes to eb canopy by bus drivers as they turn into the bus stop and navigate the bus to algin parallel (as much as they can) to the kerb to load/unload customers.

This canopy at 338 Jackson Street has been an issue for bus for a long time- meaning that we have had multiple drivers strike the canopy because of its proximity to the kerbline, combined with the bus swing path- and the introduction of newer/different buses that have different swing paths.

We are planning to build out the kerbline at the existing bus stop location outside 228 Jackson Street to keep buses away from this canopy in future- this is scheduled to be completed within the next 12 months

However- due to the most recent strikes to the canopy (in past couple weeks)- I have had to relocate the stop temporarily (until we can carry out the kerb build out at the existing bus stop) due to health and safety reasons- if drivers happen to strike the canopy again, then the canopy could fail and fall on someone underneath it- we just cant take that risk!

I see from the email trail below you are planning to remove the canopy at 338 Jackson Street? Can you confirm what the story is here?

Can you also confirm we are talking about the same canopy- the one below?

Hi Susannah, I hope you are well.
I spoke to someone yesterday about this and they said I'd need to talk to someone in that infrastructure team so I'm wondering if you could help/point me in the right direction?
The bus stop has been moved temporarily as you will be aware and common sense would say that it should stay where it is now permanently rather than widening the footpath. One reason (of many) is when the footpath is widened the bus will then stop in the middle of the main road and I'm pretty sure it would cause absolute chaos o both sides of the road.
Where it is temporarily located the buses can pull over completely out of the way of traffic safely and the building don't have canopies so there is no public safety risk either.
There are a multitude of reasons why it should be permanently located where it is now and I'd love to talk to someone about that, I'm also happy to take photos and send those to explain my case above as those may explain my case better.
I'd also be happy to come in for a chat or meet anyone out on location to discuss, as it just makes so much sense when you see it! The current set-up of the temporary stop and car parks makes sense and the area already feels like it flows so much better.

#### Kia Ora tatou

You will no doubt have seen a post from Chris Bishop over the weekend regarding the change to a bus stop on Jackson Street. I wanted to take the opportunity to explain the wider context and then specifically Jackson Street.

We have thousands of bus stops around the region and these require road markings and some sort of traffic resolution to change. Both markings and resolutions are in the hands of the local TAs. Many of these stops need to be changed for the following reasons:

- 1. The placement of the stop is wrong we have a policy to have a stop every 400m. Meeting this policy can be challenging with the existing placement
- 2. The size of the stop is too small. Whist we can apply discretion with bus stop dimensions, the NZTA guidance requires an entry taper of 15m, a bus stop box 15m and an exit taper of 9m which allows our vehicles to pull off the road properly and re-enter traffic safely. If the bus stop is not big enough, and there are car parks either side, then the bus cannot pull into the kerb and stays in the road and obstructs traffic
- 3. The bus needs to be able to pull into the kerb and 'kneel' for our accessibility passengers. Our accessibility charter is clear regarding our intent and the bus stops need to be able to facilitate this. Currently, a large number do not.
- 4. A safety issue. Our operators often raise these and we need to assess them in terms of impact and frequency. The main issue we face with respect to safety are obstructions in and around the stop that, if collected hard enough or frequently, can put our passengers and bystanders at significant risk. Many of these types of concerns relate to shop canopies, where repeat strikes weaken the structure and render them extremely vulnerable to collapse. In these cases, if we assess the risk as significant, we work with the TA to create a temporary change to mitigate the risk whilst we go through the formal Traffic Resolution process. This type of change can, and should, be done quickly and only directly affected stakeholders are notified.

All changes above, where permanent, need formal consultation and a traffic resolution – from the relevant TAs. We have a robust process for such consultation, working with the TAs, and continue to tweak it as required where we identify improvements. We also have plans that are shared with each of the TAs that identify the changes we want to make. This process is a collective one between Metlink and the TAs as the TAs own the roads and all of the associated data.

Before I explain Petone, I would point out that the changes driven by 1-3 above are often stopped when we need to remove car parks. We work closely with the TA Officers and local communities to socialise, consult, and obtain buy in to the change. However, we are often not able to actually implement the changes if there are dissenters in the community. Whether it goes ahead is entirely up to the local TA (via the traffic resolution process) and their appetite to override the dissenters. This does mean that progress on our accessibility charter for our bus network will remain challenging and our bus fleet will, in some areas, continue to impede traffic or stop in places that do not result in the most efficient running.

Now to Petone. This change was implemented as a result of 4 above – a safety issue. The offending hazard was a canopy at the site of the previous stop that has been struck a number of times over the last 2 years. We have identified this as an area for a planned kerb build out, to avoid buses striking the canopy. However, we became aware in the last 1-2 weeks that there have been more recent and multiple hits to the canopy. As such, we deemed it to be a significant safety risk and needed to relocate it using the emergency provisions until we can complete the kerb change. In accordance with our usual process, we sent out a notification to the businesses affected on 17 August and followed up by speaking directly with the owners of the businesses. We notified HCC of our intention to move the sign on Monday (today) as our contractor could not move it earlier. However, their road marking contractor made the changes earlier so the implementation of the road marking change and the signage change did not coincide.

HCC was fully aware of this issue and the change. Chris Bishop did not ask any questions or reach out to us prior to posting this on Facebook (despite having been in a meeting with Fiona earlier in the week, where carpark impacts were discussed, and having her contact details) so unfortunately we could do very little once he posted.

We will contact HCC officers to review what has happened here and confirm that all parties followed the correct processes.
